

ARTICLES OF INCORPORATION

OF

NENA'S VILLA OZ FUND, INC.

ARTICLE I - NAME

The name of the corporation is Nena's Villa OZ Fund, Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of investing in Qualified Opportunity Zone properties under the Florida Business Corporation Act of the State of Florida, and to engage in the business of leasing, selling and/or renting storage spaces.

ARTICLE III - CAPITAL STOCK

The authorized capital stock of this Corporation shall consist of the following classes:

- (a) <u>Class A Common Stock</u>. The Corporation is authorized to issue 100 shares of Class A Common Stock, \$.01 par value. Except as otherwise provided by the Florida Business Corporation Act, each outstanding share of Class A Common Stock is entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.
- (b) Class B Common Stock. The Corporation is authorized to issue 900 shares of Class B Common Stock, \$.01 par value. Except as otherwise provided by the Florida

Business Corporation Act, outstanding shares of Class B Common Stock shall have no voting rights.

(c) <u>Rights and Preferences</u>. Except with respect to voting, shares of Class A Common Stock and Class B Common Stock shall have the same rights and preferences.

ARTICLE IV - INITIAL REGISTERED AGENT
