**Articles of Incorporation
of

Pursuant to Florida Statutes Section 607.0201 and Section 607.0202, the undersigned hereby submits the following Articles of Incorporation of Sureshot Redemption, Inc., a corporation being organized under the laws of the State of Florida.

ARTICLE I.

Name

The name of the Corporation is "Sureshot Redemption, Inc." (hereinafter called the "Corporation").
