ARTICLE 1  
NAME

The name of the corporation (the "Corporation") is: **WETRADE INC.**

ARTICLE 2  
PURPOSE

The general purpose for which the corporation is organized is to transact any or all lawful business.

ARTICLE 3  
PRINCIPAL OFFICE; REGISTERED OFFICE

The address of the principal office of the Corporation and the mailing address of the Corporation is 1317 Edgewater Dr #5782, Orlando, FL 32804. The address of the register office is Law Offices of Anna Krimshstein, PLC, 2203 NE 203rd Terrace, Miami, Florida 33180.

ARTICLE 4  
CAPITAL STOCK

The total number of shares of stock the Corporation shall have authority to issue is 10,000,000 (ten million) shares of common stock at \$0.0001 par value per share.

ARTICLE 5  
DIRECTORS

This corporation shall have one (1) director. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one. The initial directors of this corporation shall be: **Shon Polishuk**.

## ARTICLE 8 LIMITATION ON DIRECTOR LIABILITY

A director shall not be personally liable to the Corporation or the holders of shares of capital stock for monetary damages for breach of fiduciary duty as a director, except (i) for any breach of the duty of loyalty of such director to the Corporation or such holders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 607.0831 of the FBCA, or (iv) for any transaction from which such director derives an improper personal benefit. If the FBCA is hereafter amended to authorize the further or broader elimination or limitation of the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the FBCA, as so amended. No repeal or modification of this Article 7 shall adversely affect any right of or protection afforded to a director of the Corporation existing immediately prior to such repeal or modification.

## ARTICLE 9 INDEMNIFICATION

The Corporation shall indemnify and advance expenses to, and may purchase and maintain insurance on behalf of, its officers and directors to the fullest extent permitted by law as now or hereafter in effect. Without limiting the generality of the foregoing, the By-laws may provide for indemnification and advancement of expenses to officers, directors, employees and agents on such terms and conditions as the Board of Directors may from time to time deem appropriate or advisable.

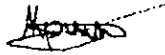
