



We, Getulio Cerro and Ramon Alexander Blanco we don't have intention of revoking the dissolution, therefore, releasing the name for use to another entity.



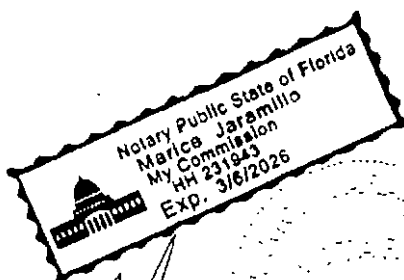


