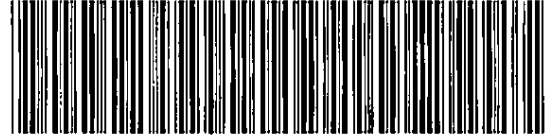

1. The first paragraph of the Agreement and Plan of Merger attached as Exhibit A to the Articles of Merger
is corrected to state that the date of incorporation of Records-CA is September 13, 1994.

2. Section 3.2 of the the Agreement and Plan of Merger attached as Exhibit A to the Articles of Merger is
amended to read as follows: "At the Effective Time, all of the previously issued and outstanding shares of
Records-FL Common Stock that were issued and outstanding immediately prior to the Effective Time
shall be automatically retired and canceled."
