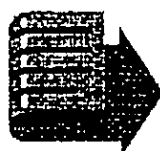
ARTICLE III - Purpose


