ARTICLES OF INCORPORATION OF SANDY BEACH REALTY AND PROPERTY MANAGEMENT, INC.

Article I - Name

The name of this corporation is **SANDY BEACH REALTY AND PROPERTY MANAGEMENT, INC.** The mailing address/principal office of the corporation is 3 Bayberry Drive, Ormond Beach, FL 32174.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes

Article IV - Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be one hundred thousand (100,000) shares of common voting stock with a par value of ten cents (\$.10) per share. All stock issue shall be fully paid.

Article V - Preemptive Rights

Every shareholder, upon the sale for eash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.



Article VI - Initial Registered Office and Agent
