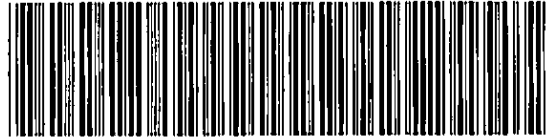

FIRST: The name of the corporation as currently filed with the Florida Department of State is GEODEL, INC. ("Company").


SECOND: The Articles of Incorporation were filed with the Florida Department of State on April 14, 2022, and assigned Document Number P22000028717.
