ARTICLES OF INCORPORATION OF BERAN CONSULTING SERVICES, INC.

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

When issued, all shares of stock shall be fully paid and nonassessable.
