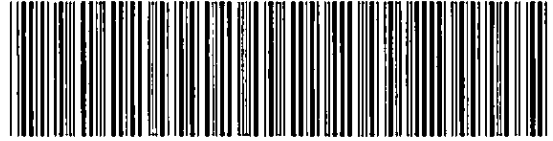

**ARTICLES OF INCORPORATION
OF
DAMU, INC.**

Pursuant to the authority of Chapter 607 of the Florida Statutes (the Florida Business Corporation Act), the undersigned, as the sole incorporator, desiring to form a corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I – NAME

The name of the corporation shall be DAMU, INC.

ARTICLE II – DURATION

The corporation shall have perpetual existence, commencing on the filing of these Articles of Incorporation.

ARTICLE III – PURPOSE

ARTICLE X – EFFECTIVE DATE

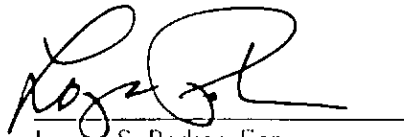
These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

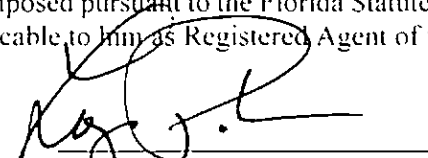
