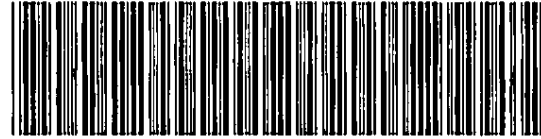

**ARTICLES OF INCORPORATION
OF
LAWGUARD SERVICES OF FLORIDA, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA") the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation:

**ARTICLE I
CORPORATE NAME**

The name of the corporation shall be LawGuard Services of Florida, Inc. (the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is to be located at 5465 Mills Civic Suite #400A West Des Moines, IA 50266.

**ARTICLE III
PURPOSE**

The Corporation is organized to transact any or all lawful business for which corporations may be incorporated under the FBCA as it now exists or may hereafter be amended or supplemented.

**ARTICLE IV
AUTHORIZATION OF SHARES**

The total number of shares the Corporation is authorized to issue and have outstanding at any time is: 100 shares, all of which shall be common stock with a par value of \$0.01/per share.

**ARTICLE V
INITIAL DIRECTORS**

The affairs of the Corporation shall be managed by a Board of Directors (collectively, the "Board" and each individual on the Board, a "Director" and collectively, the "Directors"), which shall have and exercise the powers of the Corporation. The initial board of directors of the Corporation shall consist of three (3) members. This may be increased or decreased from time to time in accordance with the Corporation's Bylaws but shall never be less than one (1). The Corporation shall indemnify, advance expenses, and hold harmless, to the fullest extent permitted by the FBCA and other applicable law as it presently exists or may hereafter be amended, any person (a "Covered Person") who was or is made or is threatened to be made a party or is otherwise involved in any action, suit, or proceeding, whether civil, criminal, administrative, or investigative, and whether formal or informal (a "Proceeding"), by reason of the fact that they, or a person for whom they are the legal representative, is or was a director or officer of the Corporation or, while a director or officer of the Corporation, is or was serving at the request of the Corporation as a director, officer, employee, or agent of another corporation or of a partnership, joint venture, trust, enterprise, or nonprofit entity, including service with respect to employee benefit plans, against all liability, damages, and loss suffered and expenses (including attorneys' fees) actually and reasonably incurred by such Covered Person. Any amendment, repeal, or modification of this Article X shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

**ARTICLE VIII
AMENDMENTS**

These Articles of Incorporation may be amended, altered or repealed by a vote of a majority of the members of the Board present and entitled to vote at a meeting of the Board, unless these Articles, the Bylaws, or the Act require a greater vote.


**ARTICLE IX


