ARTICLES OF INCORPORATION

OF

MEDKATZ DEVELOPMENTS, INC.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation ("Articles") to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be:

Medkatz Developments, Inc. (the "Corporation").

ARTICLE II

The purpose for which this Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act (the "Act").

ARTICLE III

The address of the principal office and mailing address of the office of the Corporation is 9319 Tibet Pointe Circle Windermere, FL 34786.

ARTICLE IV

The authorized capital stock of this Corporation and the maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one million (1,000,000) shares of common stock having no par value.

ARTICLE V

The street address of the Corporation's registered office is 417 E. Virginia Street, Suite 1 Tallahassee, FL 32301, and the name of the initial registered agent of the Corporation at that address is Your Capital Connection, Inc.

ARTICLE VI

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time by the Board of Directors. The Board of Directors shall be Omar Meddaoui and Jacob Katz.

ARTICLE VII

A director or officer of the Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director or officer, except for liability (i) for any breach of the director's or officer's duty of loyalty to the Corporation or its shareholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 607.0834 of the Act as the same exists or hereafter may be amended, (iv) for violation of a criminal law, unless the director or officer had reasonable cause to believe his conduct was lawful or had no reasonable cause to believe his conduct was unlawful or (v) for any transaction from which the director or officer derived an improper personal benefit.

The Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
