# ARTICLES OF INCORPORATION OF MOMA LAKE, CORP.

22 MAY -5 NM 9: 0

Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business-Corporation Act"), the undersigned incorporator, for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

#### ARTICLE 1 NAME

The name of the corporation is MOMA LAKE, CORP. (the "Corporation").

## ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Corporation is perpetual and its principal place of business is at 407 Lincoln Road PH-NE, Miami, FL 33132. The Corporation may also maintain an office or offices at such other place or places, either within or without the State of Florida as may be determined, from time to time, by the Board of Directors.

### ARTICLE 3 MAILING ADDRESS

The Corporation's mailing address will be at 407 Lincoln Road PH-NE Miami Beach, FL 33139.

### ARTICLE 4 PURPOSE

The purposes for which the Corporation is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

#### ARTICLE 5 SHARES OF STOCK

The total number of shares of capital stock that the Corporation shall have authority to issue is One Hundred Thousand (100,000), all of which are to be common stock with par value of \$1.00 per share.

## ARTICLE 6 REGISTERED OFFICE AND REGISTERED AGENT

### ARTICLE 7 DIRECTORS AND MANAGEMENT

9.1. Any repeal or modification of the foregoing provisions of this Article 8 shall not adversely affect any right or protection of a director or agent of the Corporation existing at the time of such repeal or modification.
