ARTICLE XVI - COMPENSATION

No Director, Officer, or Employee of this Corporation shall receive compensation of any type from or because of this Corporation or any subsidiary of this Corporation or from a combination of this Corporation and a subsidiary of this Corporation in total excess of \$125,000 (to be calculated in 2022 dollars) annually. This paragraph is irrevocable and cannot be altered by either an amendment to the Articles of Incorporation or by the Bylaws of the Corporation.

This Amendment is adopted this 15th day of September, 2022 by the written agreement of all of the Shareholders and all of the Directors of the Corporation, as evidenced by the signatures below, and shall become effective upon the filing with the Florida Secretary of State.
