#### ADDITIONAL SHEET

1. The following provisions shall be added to the end of Article III:

Notwithstanding the foregoing, the corporation shall be considered a Special Purpose Entity. For purposes hereof, a "Special Purpose Entity" means a corporation which since the date of its formation and at all times prior to, on and after the date thereof, has not and shall not:

- (i) engage in business other than owning a 100% membership interest in Nordic Resource Center LLC;
- (ii) acquire or own a material asset other than a 100% membership interest in Nordic Resource Center LLC and incidental personal property;
- (iii) commingle its assets with the assets of any other person or entity, or maintain assets in a way difficult to segregate and identify:
- (iv) fail to hold itself out to the public as a legal entity separate from any other;
- (v) fail to conduct business solely in its name;
- (vi) fail to maintain records, accounts or bank accounts separate from any other person or entity;
- (vii) file or consent to a petition pursuant to applicable bankruptcy, insolvency, liquidation or reorganization statutes, or make an assignment for the benefit of creditors without the unanimous consent of its shareholders, partners or members, as applicable;
- (viii) incur indebtedness except for trade payables incurred in the ordinary course of business;
- (ix) dissolve, liquidate, consolidate, merge or sell all or substantially all of its assets; or
- (x) modify, amend or revise its organizational documents without the written consent of Lender.
- 2. The following provisions shall be added as new Article IX:
  - (i) Lender is an intended third-party beneficiary of these Articles of Incorporation; and
  - Until the Loan is paid in full, these Articles of Incorporation shall not be amounted without the prior written consent of Lender.
- 3. The following provisions shall be added as new Article XI:
  - ORIGINATOR, LLC, a Delaware limited liability company, together with its successors and assigns.
  - (ii) "Loan" means that certain Loan from Lender to Nordic Resource Center LLC in the maximum principal amount of \$24,371,000.00.
