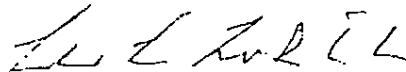
ARTICLE IX

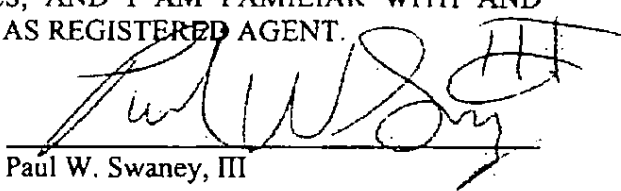
