Articles of Incorporation
of

The undersigned incorporator, for the purpose of forming a Florida profit corporation, under the Chapter 607, Florida Statutes, hereby makes, acknowledges, and files these Articles of Incorporation:

1. **Article I Name.** The name of the corporation shall be: **Nutrition Ventures Inc** (the "Corporation").

2. **Article II Principal place of business address and mailing address:** The principal place of business of the Corporation is 19595 NE 10th Avenue, Suite 5G, Miami, Florida 33179, and the mailing address of the Corporation is 19595 NE 10th Avenue, Suite 5G, Miami, Florida 33179.

3. **Article III Duration.** The period of duration of the Corporation shall be perpetual unless dissolved according to the law.

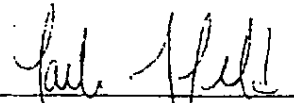
