The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

**ARTICLE I.**

**ARTICLE II.**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this Corporation shall be: 18459 PINES BLVD. STE. 276, PEMBROKE PINES, FL. 33029.

**ARTICLE III.**

**PURPOSES**

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV.****CAPITAL STOCK**

The maximum number of shares that this corporation is to have outstanding at any one time is One thousand (1,000) shares of common stock, having a nominal or par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the board of directors but in no event shall be less than \$1.00.

**ARTICLE V.****TERM**

This corporation shall commence existence on the date of the filing of these Articles of Incorporation and shall have perpetual existence.

**ARTICLE VI.****REGISTERED AGENT AND REGISTERED OFFICE**

The Registered Agent for this corporation shall be GABRIEL OSCAR HERMOSO and the Registered Office shall be located at 18459 PINES BLVD. STE. 276, PEMBROKE PINES, FL. 33029 or at such other place as the Board of Directors shall from time to time direct, with appropriate notice being given to the Secretary of State in accordance with the law.

**ARTICLE VII.****DIRECTORS**

#### **ARTICLE VIII.**

##### **INSPECTION OF BOOKS AND RECORDS**




