The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.

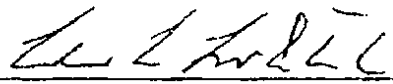

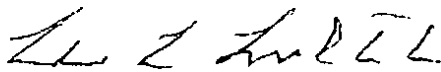
