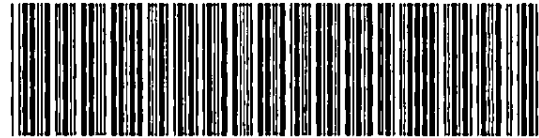

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is **CHŌWA HOME, INC.**


