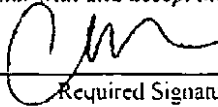

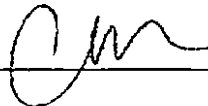

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 15000 of which 10000 shares of par value 0.001 per share shall be designated as Common Stock and 5000 shares of par value 0.001 shall be designated as Preferred Stock.
