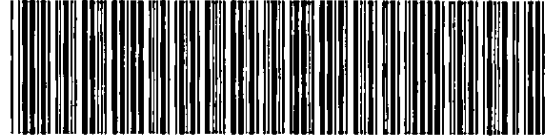


#### ARTICLE X

Pursuant to the provisions of Chapter 607 of the Florida Statutes, this Corporation shall begin its existence upon the date of filing of these Articles of Incorporation.


