I, the undersigned, hereby file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit pursuant to the laws of the State of Florida.

## ARTICLE I Name and Address

The name of this corporation shall be:

#### FLORIDA ADOPTION AND SURROGACY ATTORNEYS, P.A.

The principal office and mailing address of this corporation shall be 418 W. Platt Street, Suite B, Tampa, Florida, 33606, or such other address within the State of Florida as the Board of Directors may from time to time designate.

## ARTICLE II Existence of Corporation

This corporation shall begin existence upon the filing of these Articles of Incorporation with the Secretary of State of Florida and shall have perpetual existence.

#### ARTICLE III Business and Purposes

The business, objects and purposes of the corporation shall be as follows:
