

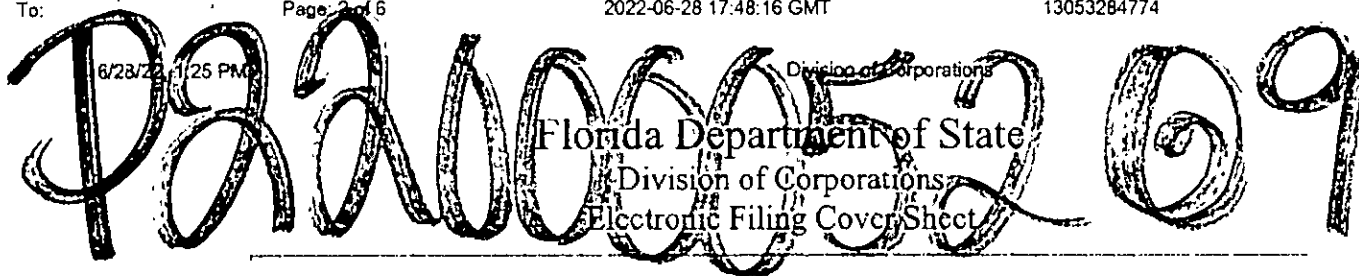

**Article I
Name**

The name of this corporation is PLASTIBLOW USA, CORP.

**Article II
Principal Office Address**


