THIRD AMENDMENT to ARTICLES OF INCORPORATION of KITCHEN CREEK CAPITAL INC.

ARTICLE IV: Number of Authorized Shares: is hereby amended by adding a new Paragraph C1.

C1: The second series of preferred stock shall be Class B which shall consist of not less than 1,450,000 shares. These are non-voting shares. The shares of class B preferred stock shall have a par value of \$1.00 per share. The shares shall be non-participating, have a 12.5% non-cumulative dividend based on par value and shall be callable on a pro rata basis at any time provided all the Class A preferred stock has previously been redeemed and further provided however that if called at any time prior to 4 years from date of issuance, the redemption price shall be equal to par value plus an amount equal to the dividends that would have been paid, had the called shares been issued for 4 years, less an amount equal to those dividends that were paid prior to redemption. The redemption price for shares called after they have been issued for 4 or more years shall be the par value plus an amount equal to the dividends that would have been paid prior to redemption less an amount equal to those that were paid.
