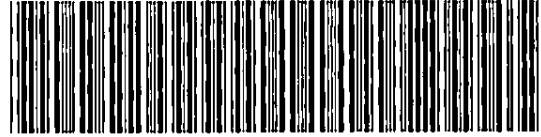

OF

The Corporation shall have authority to issue One Thousand Five Hundred (1,500) shares of Common Stock having a par value of \$1.00 per share.


