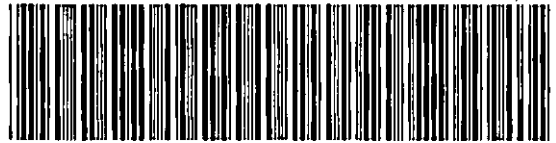



ARTICLES OF INCORPORATION

OF

On The Dotted Line Plus, Inc.

ARTICLE I- NAME

The name of this corporation is **On The Dotted Line Plus, Inc.**

ARTICLE II – DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III – PURPOSE

ARTICLE XI – INDEMNIFICATION



ARTICLE XII – AMENDMENTS


