





ARTICLES OF INCORPORATION



ADELPHI TRUST COMPANY

The undersigned, acting as directors for the purpose of forming at corporation.

SECRETARY OF STATE of the undersigned, acting as directors for the purpose of forming at corporation.

ARTICLE I

The name of the corporation shall be Adelphi Trust Company and its initial place of business shall be at 100 Second Avenue South, Suite 1204S, in the City of St. Petersburg, in the County of Pinellas and State of Florida.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be: That of a general trust company business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of trust companies.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 250,000. Such shares shall be of a single class and shall have a par value of \$20.00 per share. The corporation shall begin business with at least \$2,000,000 in paid-in common capital stock to be divided into 100,000 shares. The amount of surplus with which the corporation will begin business will be not less than \$2,000,000 and the amount of undivided profits, not less than \$-0-all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

<u>Preemptive Rights Clause</u>: No shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for a pro rata portion of any stock of any class that the corporation may issue or sell.

ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

ARTICLE V

The number of directors shall not be fewer than five (5). A majority of the full board of directors may, at any time during the years following the annual meeting of shareholders in which such action has been authorized, increase the number of directors by not more than two and appoint persons to fill resulting vacancies.
