**ARTICLES OF AMENDMENT TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
A. I. SCHARE, M.D., II, P.A.
(Document No. P22000058863)**

A. I. SCHARE, M.D., II, P.A. (the "Corporation"), pursuant to Section 607.1006, Florida Statutes, does hereby file the following Articles of Amendment:

1. The name of the Corporation is A. I. SCHARE, M.D., II, P.A.
2. Article V of the Amended and Restated Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

**Article V
Shareholder Restrictions**

No one other than an individual who is duly licensed or legally authorized to render medical services in the State of Florida may own stock of this professional corporation. No shareholder of this professional corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of her stock. Any stockholder who becomes legally disqualified to render medical services shall sever all employment with and financial interest in the professional corporation. No shareholder shall transfer any shares of stock of the professional corporation, except to another individual who is eligible to be a shareholder of the professional corporation.

3. The foregoing amendments were adopted on February 3, 2023 by written consent of the sole director then in office.
