ARTICLES OF INCORPORATION OF ACQUA MARINA INVESTMENTS, CORP.

Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned incorporator, for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of the corporation is Acqua Marina Investments Corp. (the "Corporation").

ARTICLE 2 DURATION, PLACE OF BUSINESS AND MAILING ADDRESS

The period of duration of the Corporation is perpetual and its principal place of business is located at 100 Bayview Dr #PH06, Sunny Isles Beach, FL 33160. The Corporation's mailing address will be at 407 Lincoln Road, Penthouse NE, Miami Beach, Florida 33139. ARTICLE 6 DIRECTORS AND MANAGEMENT

Subject to the provisions of the Florida Business Corporation Act, the following provisions are adopted for the management of the business and for the conduct of the affairs of the Corporation, and for defining, limiting and regulating the powers of the Corporation:

6.1. The name of the Corporations' Directors are:

- 6.2. The number of directors of the corporation constituting the Board of Directors may be fixed by the bylaws.
