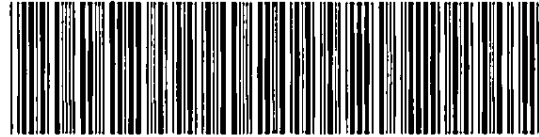

Article 3: Purpose

Article 5: Bylaws

Any director shall be removed from office with or without cause by the vote or agreement in writing by a majority of all the board of directors or as more specifically set forth in the Bylaws.
