**ARTICLES OF INCORPORATION
OF
CERES TALENT, INC.**

The undersigned incorporator, H. Britt Landrum, III, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is CERES TALENT, INC. The Corporation is referred to in these Articles of Incorporation as the "Corporation."

ARTICLE II - PRINCIPAL OFFICE

The address of the initial principal office and the initial mailing address of the Corporation is 219 E. Garden Street, Suite 500, Pensacola, FL 32502.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue one thousand (1,000) shares of \$1.00 par value common stock.

ARTICLE V - TERM OF EXISTENCE

The Corporation shall have perpetual existence.

ARTICLE X – AMENDMENT




