Articles of Incorporation B.J. Anarumo, D.O., P.A.

## Article III Purpose

The purpose for which the corporation is organized is:

- a. To engage in the practice of medicine as a professional corporation and to operate a medical clinic for the purposes of providing medical care and treatment, including but not limited to the practice of pediatric medicine.
- b. To associate or otherwise contract with other physicians, professional service corporations, hospitals, health care providers, health maintenance organizations, independent physician associations, physician provider organizations and other entities, associations or mediums necessary or helpful for the provision of healthcare service to patients.
- c. To promote medical, surgical and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional medical services.
- d. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporation purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licenses or otherwise legally qualified to render professional medical services in the State of Florida.
