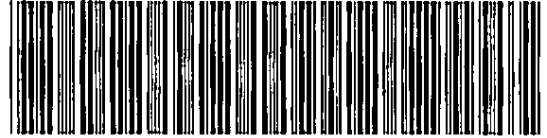

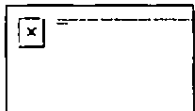
Hello Daniel


