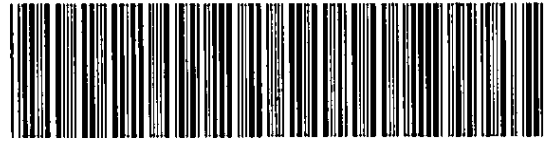

Dear Mr. Pearlman:

Thank you for your recent correspondence requesting approval for use of the above-referenced name.

Section 655.922, Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name. While My Bank, Inc. is not a chartered financial institution at this time, the intent is for the name to be used in connection with a financial institution in organization. Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, this correspondence is not intended to grant the authority to act in any licensed or chartered capacity until all chartering requirements have been met within this state.
