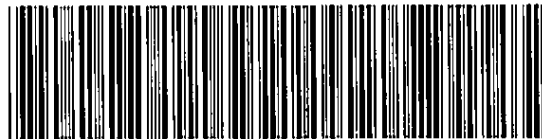

ARTICLES OF INCORPORATION
OF
ADVENIR@CALLAWAY GP, INC.

ARTICLE I

Name

The name of the corporation is Advenir@Callaway GP, Inc. (hereinafter called the "Corporation").

ARTICLE II

Principal Office

The address of the principal office and the mailing address of the Corporation is 17501 Biscayne Boulevard, Suite 300, Aventura, Florida 33160.

ARTICLE III

Capital Stock


ARTICLE VIII


