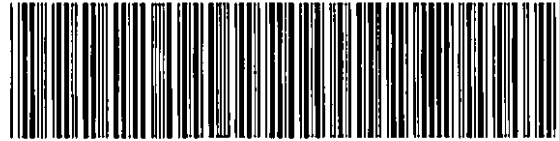



SECOND: The Converting Entity is a limited liability company first organized and formed under the laws of the State of Florida on September 20, 2022.


THIRD: The name of the Corporation as set forth in the attached Articles of Incorporation is Career Resources, Inc.



**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of CAREER RESOURCES, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name and street address of the incorporator is James Gutierrez, 333 S. E. 2nd Avenue, Suite 2000, Miami, FL 33131.


ARTICLE IX. BYLAWS


