**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
CAREER RESOURCES, INC.**

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of CAREER RESOURCES, INC., a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Career Resources, Inc.

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the entire Article I as it now exists and inserting in lieu thereof a new Article I. reading as follows:

"ARTICLE I. NAME

The name of the Corporation is Go To Personnel Training, Inc."

THIRD: The effective date shall be the date these Articles of Amendment to the Articles of Incorporation are approved by the Florida Secretary of State.
