The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be RTR SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the principal office of the Corporation is 6124 Hanging Moss Road, Suite 300, Orlando, Florida 32807. The mailing address of the Corporation is P.O. Box 536182, Orlando, Florida 32853.

ARTICLE III - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE IX - DATE OF EXISTENCE


