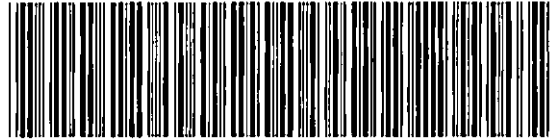

**ARTICLES OF INCORPORATION**  
**OF**  
**GOA HOLDINGS, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "Act"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is Goa Holdings, Inc. (the "**Corporation**").

**ARTICLE II: INITIAL PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is 1640 Presidential Way, Apt. 501, West Palm Beach, Florida 33401. The mailing address of the Corporation is the same as the street address of the initial principal office of the Corporation set forth herein.

**ARTICLE III: SHARES**

The aggregate number of shares which the Corporation is authorized to issue is 2,500,000, with each share having a par value of \$1.00. The shares shall all be common shares and there shall be no other class or classes of shares. All or any part of such shares may be issued by the Corporation from time to time, as may be determined by the Board of Directors, as provided by law.

**ARTICLE IV: INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the Corporation is 1640 Presidential Way, Apt. 501, West Palm Beach, Florida 33401. The name of the initial registered agent of the Corporation at that office is Achintya Bhattacharjee, a resident of Florida and a director of the Corporation.

**ARTICLE V: INCORPORATOR**

The name and address of the Corporation's incorporator is: Achintya Bhattacharjee, 1640 Presidential Way, Apt. 501, West Palm Beach, Florida 33401.

**ARTICLE VI: PURPOSE**

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Act.

## **ARTICLE VII: DURATION**

The period of the Corporation's duration is perpetual.

## **ARTICLE VIII: DIRECTORS**

The number of directors constituting the initial Board of Directors of the Corporation is one. The name and address of the director of the Corporation until the first annual meeting of shareholders or until any successor is elected and qualifies is: Achintya Bhattacharjee, 1640 Presidential Way, Apt. 501, West Palm Beach, Florida 33401.

## **ARTICLE IX: INDEMNIFICATION**

The Corporation shall indemnify its directors and advance their expenses to the fullest extent permitted by the Act, as it may be amended or modified from time to time. This Article is meant to create vested rights, enforceable by each person who serves on the Corporation's board of directors and his or her successors in interest, that cannot be affected adversely by (a) the person ceasing to be a director or (b) this provision being amended or repealed after the acts or omissions giving rise to the claim for which indemnity or advancement of expenses is sought.
