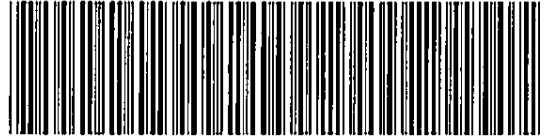

Because Meraki Marketing Kft. is a business entity, it cannot serve as an officer of the corporation.


Meraki Marketing Kft. was added in error, and should be removed.
