ARTICLES OF AMENDMENT

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of MEH SURVEY, INC., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of MEH SURVEY, INC., and upon authority of all of the shareholders of MEH SURVEY, INC., hereby set forth as follows:

1. The name of this Corporation is MEH SURVEY, INC.
2. The Articles of Incorporation of MEH SURVEY, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article I:
