

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 1,100,000,000 of which 1,000,000,000 shares of par value \$0.001 per share shall be designated as Common Stock and 100,000,000 shares of par value \$0.001 shall be designated as Preferred Stock.
