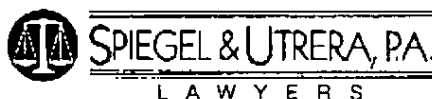
**ARTICLE 14 - EFFECTIVE DATE**


