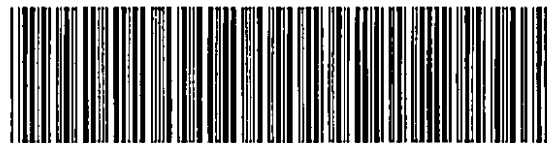

**ARTICLES OF INCORPORATION
OF
INJECTABLE AESTHETICS, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be INJECTABLE AESTHETICS, INC. (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE

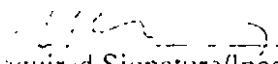
