**ARTICLES OF INCORPORATION
OF
IMAN NASERI, M.D., P.A.**

The undersigned incorporator, for the purpose of forming a corporation in the State of Florida hereby adopts the following Articles of Incorporation.

**Article I
Name and Duration**

The name of this corporation is Iman Naseri, M.D., P.A. ("Corporation"). The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be January 1, 2023.

**Article II
Principal Office**

The address of the principal office and mailing address of the Corporation in the State of Florida is 6817 Southpoint Parkway, Suite 502, Jacksonville, Florida 32216.

**Article III
Capital Stock**

The maximum number of shares of stock which this Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.
