(a Florida corporation)

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of FIRST MILE INSURANCE COMPANY, a corporation being organized under the laws of the State of Florida.

ARTICLE I. Name

The name of the Corporation is "FIRST MILE INSURANCE COMPANY" (hereinafter called the "Corporation").

ARTICLE II. Purpose & Duration


