ARTICLES OF INCORPORATION OF COOPER'S POND ROAD COMPANY, INC.

The undersigned Incorporator hereby file these Articles of Incorporation in order to form at Corporation under the laws of the State of Florida.

Article 1. Name and Principal Office

The name of this Corporation shall be **Cooper's Pond Road Company**, **Inc.** The principal place of business and mailing address of this Corporation shall be 2400 Oakdale Street, Tallahassee, Florida 32308.

Article 2. Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

Article 3. Stock

The authorized capital stock of this Corporation shall consist of one hundred (100) shares of voting common stock with no par value per share. The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors, but not less than par value. Each issued and outstanding share of voting Common Stock shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the Shareholders of the Corporation. No contract or other transaction between the Corporation and one or more of its Directors or officers or between the Corporation and any other Corporation, firm, or entity in which one or more of the Corporation's Directors or officers are Directors, or officers or have a financial interest, shall be void or voidable solely because of such relationship or interest or solely because such Director or Directors or officer or officers is present at or participates in the meeting of the Board of Directors or a committee that authorizes, approves, or ratifies such contract or transaction or solely because his or their votes are counted for such purpose, if:
 - A. The fact of such relationship or interest is disclosed or known to the Board of Directors or the committee that authorizes, approves, or ratifies the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of such interested Director or Directors; or
 - B. The fact of such relationship or interest is disclosed or known to the Shareholders entitled to vote thereon and they authorize, approve, or ratify such contract or transaction by vote or written consent; or
 - C. The contract or transaction is fair and reasonable as to the Corporation at the time it is authorized by the Board of Directors, a committee thereof, or the Shareholders.
