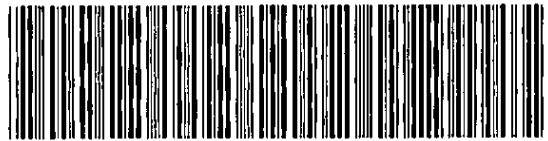

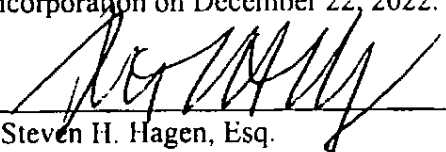
ARTICLE VIII. BYLAWS
