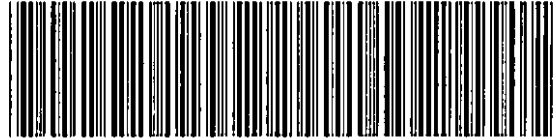

ARTICLES OF INCORPORATION  
OF  
RIVERVIEW SMILES DENTISTRY, PA

Pursuant to Chapter 621 of Florida Statutes, as amended from time to time (the "Act"), the undersigned incorporator adopts the following articles of incorporation:

ARTICLE I  
Corporate Name

The name of the Corporation is Riverview Smiles Dentistry, PA.

ARTICLE II  
Purpose

The sole and specific purpose of the Corporation is to render professional dental services. The Corporation may engage in such other activities as may be authorized under the Act.

ARTICLE III  
Authorized Shares

The Corporation is authorized to issue 100,000 shares of common stock.

ARTICLE IV

This Article IV shall not be deemed exclusive of any other provisions for indemnification or advancement of expenses of directors, officers, employees, agents and fiduciaries included in any statute, bylaw, agreement, general or specific action of the board of directors, vote of shareholders or other document or arrangement.

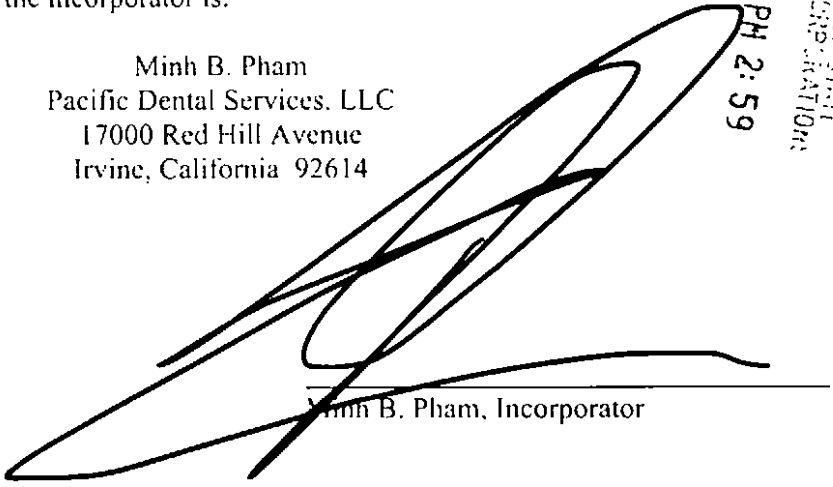
